## Issue and Return of Ballot Papers and Voting Information

Voting information will be issued by email to those members who have provided the Trust with a valid email address. Ballot papers will be issued by post to all other members in eligible constituencies. All members will be able to vote via the internet at www.mi-vote.com/secure, using the unique voter code contained in the email or printed on the ballot paper. Members who receive a postal voting pack will also have the option of voting by post. All votes, whether cast via the internet or by post, must be received by the Returning Officer by 5.00pm on Tuesday 02 July 2024. **Lost Ballot Papers** If a voter has not received his or her voting information email or ballot paper by **Wednesday 26 June 2024** an application may be made to the Returning Officer for a replacement.

**Spoilt Ballot Papers** If a voter spoils his or her ballot paper an application may be made to the Returning Officer for a replacement. Replacement voting information may be issued by email until the close of poll.
